Reimagining Copper Recycling for India's Circular Economy

Shri Mayur Karmarkar (MD, ICA India) participated in an insightful panel discussion on "Extended Producer Responsibility: Promise vs Practice in India's Recycling Future" at the **Bharat Recycling Show 2025** in Mumbai.

He shared key perspectives on EPR and copper recycling in India, drawing from ICA India's research and on-ground understanding of the ecosystem.

The key takeaways were:

- While EPR is a crucial policy lever, its impact on the availability of more EoL copper scrap is limited. ICA India's Copper Stock & Flow Model shows that the EoL copper scrap collection and recycling rate in India is already more than 90%.
- This high collection efficiency & recycling efficiency is due to the contribution of India's informal sector. Even a rag-picker can identify copper due to its distinct colour and value. Copper's use in bulk conductor applications—cables, transformers, motor windings—provides the material volumes that make recovery economically attractive, achieving high recycling rates in India.

However, the challenge lies in channeling this efficiently collected scrap into the formal recycling ecosystem.

Yesterday's panel discussion "From Fast Fashion to Forever Fibers: Threaded Circularity in Textile Recycling" at the **Bharat Recycling Show**, Mumbai. It was an engaging conversation on how India's textile industry can shape the future of circularity at a global scale.

As someone deeply rooted in manufacturing and exports, I firmly believe India is at a defining moment. Global fiber production continues to grow, yet recycled fibers remain a small share of the overall mix. The shift toward circularity is accelerating due to regulatory momentum, global brand commitments and rising consumer expectations.

During the discussion, I highlighted a few priority areas that can truly move the needle:

- Building modern collection and sorting infrastructure to ensure high-quality feedstock
- Establishing unified national standards and HS codes for recycled fibers
- Creating targeted incentives and co-investment models to expand recycling capacity
- Formalising and upskilling the informal collection ecosystem
- Strengthening collaboration across manufacturers, recyclers, brands and policymakers
- Traditional textile players and recyclers must work in deeper partnership. Long-term offtake agreements, shared investments, accredited lab testing and digital traceability will be essential for making recycled fibers both cost-competitive and consistent in quality.

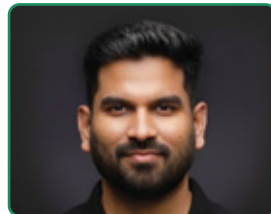
